These guidelines are recommended for the proper installation of Oasis products. A careful review of these procedures (and any referenced publications) before starting is important in avoiding an improper assembly and/or installation.

NOTE: All illustrations in this publication are typical, and may appear different than the actual product. Optional items may also be shown that were not ordered on the product being installed.

INSPECTION GUIDELINES

Carefully check the unit upon receipt. Notify your supplier immediately if any questions or problems are encountered during this process.

DO NOT INSTALL PRODUCT WITHOUT FIRST ADDRESSING QUESTIONS WHICH ARISE DURING THE INSPECTION!

Basic Module Check

- Check unit drain position for match to bathroom drain location.
- Check unit for surface damage.
- Check wall section(s) and base for color match.
- Check unit color for coordination to other bathroom fixtures.

INSTALLATION SITE FRAMING


The recommended framing and dimensional requirements shown are for a traditional application and may vary, based on site requirements.


The dimensions shown in the dimensional diagram (illust. 1) are from the surfaces where the unit will be attached. This surface can be bare studding, dry wall or other suitable under layment material. It is important that the floor and all framing be square, plumb and level. Framing must be done using accepted materials and construction techniques in accordance with all applicable codes for the site.

WARNING: Alcove framing members cannot tilt, angle or protrude into the area intended for the three (3) individual unit sections to occupy, as this can compromise proper alignment of the VURSA kd sections.

NOTE: Any pre-constructed wall(s) may require modification or additional framing to allow for factory applied pipes and/or fittings which may protrude from the body of the unit.

NOTE: A minimum of 48-inches of drywall must be removed from the framing area in order to place the components in the alcove.

INSTALLATION PROCEDURE

The VURSA kd, multi-piece system is designed as a front side installation procedure, with three (3) individual sections locking securely together.

Factory-installed pegs have been positioned on the top ledge of the base and midsection components, and align with holes on the underside of the mid and top-sections. Each hole has been fitted with a unique connector which locks to the peg.

The connection process provides an audible "CLICK" when each peg and insert are mated, resulting in compression along the seam.

SPECIAL NOTE:

Move base section forward within the alcove by applying 1/8-inch thick shims behind the attachment flange across the entire back wall (illust. 3).


SPECIAL INSTALLATION NOTE:


Our minimal threshold shower stall design does not require a floor recess. The normal installation will have small irregular spaces between the underside of the shower and the sub-floor where a non-shrinking leveling material, followed by the use of weight across the shower floor during the curing process, is required to fill the voids. A proper installation will fill only the voids without creating unwanted upward distortion in the designed floor slope required for proper drainage. Properly filling the voids is important in addressing repeated long-term weight transfer from wheelchairs, along with proper drainage.


In addition, the floor drain cutout for a minimal threshold shower must be large enough to allow the shower floor to retain the designed continuous slope to the drain. The application of the drain connection is also critical for proper installation. The position of the drain and connections must not allow the shower floor to be pushed upward. Any upward distortions created by the filler material, the sub-floor or the drain assembly on the shower floor will compromise drainage. (illust. 1 & 2)

Confirm drain fitting and drain pipe alignment prior to application of leveling material in the alcove.

- Before placing unit in the framed alcove, spread a 1/4"-1/2" layer of leveling material around the drain cutout, extending out to the perimeter of the alcove area (illust. 2).
- Install the drain fitting to the drain opening of the unit.
 DO NOT STAND THE SHOWER UNIT ON THE DRAIN FITTING!
- Position the unit directly on the leveling material checking for proper drain fitting and drain pipe alignment (illust. 3).







- Confirm the threshold and floor mounting flange are resting flush on the floor.
- Confirm the unit is level along each side and across each end (illust. 4).

NOTE: The use of shims behind the attachment flanges may be required to ensure the base component remains square and plumb in the framed area. Caution must be used to avoid distorting the unit shape which can affect alignment of the VURSA kd sections.

THE BASE MUST BE LEVEL, SQUARE AND PLUMB TO INSURE PROPER FIT OF THE UPPER SECTIONS!

1. Drill a 1/8" hole through the flange at each framing member. Attach the flanges across the back first, followed by the ends and then along the front vertical flanges, using 1-1/4" long nails or other appropriate fasteners (photo 1), approximately 7"-9" apart. Continually check to make sure the base component remains square and plumb

within the framed area as it is being secured to ensure proper alignment for the upper sections

Attachment of the floor mounting flange to the room floor will also be required using the same method as directed for the wall flanges.

NOTE: Usage of a thin shield to protect the unit surface while fastening it to the framing is recommended.

Protect the inside floor surface using a large cardboard and apply weight on top of drain until base material dries (illust. 5).

2a. With the leveling material cured and the base component securely attached to the framing, dry-fit the mid-section to confirm proper alignment, and identify any required shim adjustments necessary for the base component.


To perform the dry-fit procedure, position the mid-section above the pegs on the base component with the front edge overhanging the base about 2-inches. Apply even pressure to the front of the mid-section on both sides, moving it back across the top of the pegs (photo 2). When properly positioned the base component pegs enter holes along the underside of the mid-section ledge and 'CLICK' in place confirming a positive connection. With the mid-section fully seated, confirm proper mating and seam alignment with the base component at the front face and across the inner sidewalls.


NOTE: The VURSA kd back wall uses offset face contouring to direct water away from the seam, intentionally eliminating flush face alignment along the back wall seam.


2b. With proper alignment confirmed, lift the mid-section off the base and out of the alcove area. Thoroughly clean the mating surfaces on both the base component and the mid-section.

NOTE: Oasis recommends a high quality silicone based sealant with a mold and mildew resistant content.


Apply a SMALL (approximately 1/8-inch wide - photo 3) continuous bead of sealant on the top ledge of the base component, beginning at the attachment flange at the first peg, along an imaginary line from pegto-peg on the shower side (photo 4). At the front corners, extend the bead at the base of the front peg to the front and back to the face of the attachment flange. (photo 5).
















3. With the mid-section securely attached to the framing, repeat the dry-fit process with the top-section to confirm proper alignment, and identify any shim adjustments required to the mid-section. (Refer to and follow steps 2a, 2b and 2c for detailed instructions, and supporting notes to complete the assembly of the top-section.)

2c. Secure the mid-section by drilling a 1/8"

(Silicone ribbons enhanced for photo visibility.)

NOTE: The use of shims behind the attachment flange may be required to ensure the mid-section remains properly aligned vertically. Caution must be used to avoid distorting the unit shape, which can affect top-section alignment.

Carefully reposition the mid-section over the pegs on the base component and listen for the audible 'CLICK' to confirm the connection. Remove any excess silicone from the seam at this time.

Water Supply and Drain Connections

Finishing Guidelines

Filler strips or filler material may be required over the framing to ensure the under layment mounts flush over the flanges. Applying filler strips or material may also be required over the floor flange for proper installation of the finished floor material (illust. 6 & 7).

A water resistant under layment is recommended surrounding the unit. Stop the under layment 1/16 to 1/8-inch from the unit surface, and fill the space with a continuous bead of water resistant sealant (illust. 6).

Use care when fastening the under layment near the unit surface to avoid damage. Seal the under layment seams and edges, as required, and install the finish material to specifications.

UNIT SURFACE CARE

WARNING! NEVER USE ABRASIVE MATERIALS. OR ABRASIVE CLEANERS ON THE UNIT SURFACE!

EXTREME CAUTION is urged regarding the use of any cleaner, acid or solvent on the unit surface.

READ AND FOLLOW PACKAGE INSTRUCTIONS FOR ALL PURCHASED CLEANING PRODUCTS!

Through routine use, the unit surface can collect residues from soap, bath additives and natural body oils. Additional deposits can also collect from minerals or particles found in the water. After each use, wipe the excess water from the unit. This practice will reduce the buildup of deposits and help maintain the natural unit lustre.

Following a thorough surface cleaning, an application of quality automotive wax will help reduce major accumulations. The actual schedule for cleaning and waxing will depend on unit usage and water quality.

<u>WARNING!</u> <u>NEVER APPLY WAX</u> <u>TO THE UNIT FLOOR!</u>

◆ <u>Routine Cleaning:</u> Mild, non-abrasive cleaner specifically formulated for gelcoat and acrylic surfaces recommended. (Rinse surface thoroughly)

- ◆ <u>Heavy Soap Deposits:</u> Liquid ammonia household cleaner, applied full strength. (Rinse surface thoroughly)
- ◆ <u>Stubborn Stains:</u> Liquid household cleaner or hydrogen peroxide applied full strength. Place a saturated clean rag directly on stain and let stand several hours. (Rinse surface thoroughly)
- ◆ <u>Hard Water Scales:</u> Liquid scale remover or white vinegar, applied full strength. (Rinse surface thoroughly)
- ◆ <u>Mold/Mildew:</u> Liquid mildew remover or baking soda and water paste. (Apply paste and allow to fizz several minutes.) (Rinse surface thoroughly)
- ◆ <u>Construction Adhesive:</u> Soften adhesive with a hand held hair dryer and peel off adhesive. (Caution is advised when using any electrical device near water.)

For adhesive residue, apply rubbing alcohol or nail polish remover, full strength. (Rinse surface thoroughly)

Oasis Lifestyle provides a performance assurance program for unit structural integrity and surface finish covering a five (5) year period from the date-of-purchase on GELCOAT, and covering a ten (10) year period from the date-of-purchase on VACUUM FORMED ACRYLIC product, for the original purchaser and subsequent consumer. This Oasis limited warranty program addresses specific defects in the product, and the workmanship associated with the manufacture of the Oasis bathing and shower product. The specific defects covered must result in a significantly altered appearance and/or affect the intended performance standards for the product under normal residential use.

Hydro-Massage Systems (water recirculation & air), Option & Accessories Limited Warranty

Oasis Lifestyle provides a performance assurance program for their hydro-massage systems (herein called 'system'), and their options and accessories covering a two (2) year period from the date-of-purchase for the original purchaser and subsequent consumer. This Oasis limited warranty program addresses specific defects in the system components, and the workmanship associated with the assembly of the systems, along with offered options and accessories installed by Oasis, on an Oasis unit. The specific defects covered must result in a significantly altered appearance and/or affect the intended performance standards for the system, the option and/or the accessory.

During the coverage period, Oasis will, at its discretion (following a verification by an authorized Oasis representative), either provide service or supply a replacement product without charge, but excluding any cost associated with the transportation, removal of and/or reinstallation of the unit (module).
